In accordance with NCUA Rules and Regulations, our independent auditor (Kwock & Company CPAs) have begun conducting annual share and loan confirmation procedures. As part of the audit process, you may have been randomly selected by our auditors.

If you were selected, you will receive the letter in the mail in early November 2022, asking you to review your statement and confirm the amount listed on the letter. Please follow the instructions on the letter and respond by returning the signed confirmation letter in the pre-paid business reply envelope addressed to 1585 Kapiolani Blvd Suite 1625, Honolulu 96814, which will be delivered directly to our auditors.



Important IRA Information

Action requested to avoid possible IRS penalties, Traditional IRA owners have required minimum distributions (RMD). If you have not already setup your RMD payment plan, or if you would like to make changes to your distribution, please contact us at (808) 244-7968. Withholding notice payments from your IRA are subject to federal income tax withholding unless you elect no withholding.

You may change your withholding election at any time prior to your receipt of a payment. To change your withholding election, complete the Traditional IRA RMD Payment Election Form available on our website. Withholding from IRA payments, when combined with other withholding, may relieve you from payment of estimated income taxes, but does not affect the amount of income tax you pay. You may incur penalties under the estimated tax rules if your withholding and estimated tax payments are insufficient.
