

Maui County Federal Credit Union's Small Business Bingo Rules

Eligibility Requirements. The random drawing is open to legal residents of Maui County. Maui County Federal Credit Union membership is not required for participation and eligibility. Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

Entry.

1. Follow @MauiCountyFCU on Instagram and/or Facebook.
2. Post a photo of your completed Bingo card along with photos of you eating at the restaurant or with your takeout order on Facebook or Instagram during the period of Tuesday, September 1, 2020 through Wednesday, September 30, 2020.
3. Tag @MauiCountyFCU and the restaurants in your Facebook/Instagram posts.
4. Use #kamaiinafirst and #maui eats on your posts.
5. Profiles must be public or email photos of your posts with captions to info@mauicountyfcu.org.
6. Each Bingo card with five spots covered qualifies as an entry, so individuals may play and enter more than one Bingo card.

Prizes. Each qualifying Bingo card will be entered to win in a drawing for a Visa \$100 gift card. Five winners will be selected at random. Prize is not redeemable for cash; no substitution is permitted. Prize is non-assignable or transferable to another individual, except to a surviving spouse. Winner is responsible for all federal, state, and local taxes, if applicable.

Odds of winning. The odds of winning will depend upon the total number of eligible entries received.

Selection and Notification of Winner. Winners will be selected on Thursday, October 1, 2020, in a random drawing from all eligible entries received. The drawing will take place at MCFCU's Wailuku Branch, 1888 Wili Pa Loop, Wailuku, HI 96793. All decisions are final.

Prize winners will be notified via social media. MCFCU will have no liability for a winner's failure to receive notices due to winner's spam, junk email, or other security settings, winner's incorrect or non-functioning contact information. Winner need not be present to win. Winners can collect their prize in person at 1888 Wili Pa Loop in Wailuku, during business hours, on or after October 1, 2020.
