

SCHOLARSHIP PROGRAM

(Revised 1/31/19)

Qualifications of Applicant(s):

1. Must be a Member of the Maui County Federal Credit Union and must continue to be a member at the time the scholarships have been awarded;
2. Applicant (Dependent) and Entitlement Member(s) must also be in Good Standing with this credit union for at least 1 year prior to the deadline for submitting the scholarship application;
3. Must be a High School Graduate or received a GED Certificate;
4. Must be enrolled as a Full-time student; and
5. Must be pursuing a Degree – Bachelors, Masters, Doctorate, Vocational.

Awardees:

1. Ten (10) \$1,000.00 individual Scholarships will be awarded. Total disbursement of all scholarships will not exceed \$10,000.00;
2. Individual Scholarship selection will be made by **RANDOM** drawing;
3. Scholarship award recipients are limited to a life-time limit of two (2) awards; and
4. Must provide Proof of Attendance with address for mailing of award.

Definitions:

1. **Entitlement Member(s)** – is the member who by virtue of his or her membership eligibility is entitled to join this credit union;
2. **Good Standing** – Member(s) is/are current with all obligations outstanding with Maui County Federal Credit Union. To be current is not to be more than ten (10) days beyond the due date of all obligations with the Maui County FCU.
3. **Full-time student** – taking twelve (12) or more credits in the school's system (quarter, semester)
4. **Proof of Attendance** – Letter of Confirmation from the school
